2.1 Child Find

22 PA Code §14.121 and 22 PA Code §711.21

1. When are school districts and charter schools responsible for child find for children parentally placed in private schools?

School districts and charter schools are responsible for child find and the offer of FAPE for all children who are residents and who are seeking eligibility for FAPE in the public schools. The intermediate units (IUs) are responsible for child find for children parentally placed in private schools for equitable participation only.
