## IDEA – WIOA

# Secondary Transition Crosswalk

This document contains examples of Pre-Employment Transition Services and School-Level Transition Services with regard to Pennsylvania’s Career Education and Work Standards (13.1-13.4): Career Awareness and Preparation, Career Acquisition, Career Retention and Advancement, and Entrepreneurship. The following provides an explanation of the chart and outlines the responsibilities for each service.

- **Purpose of the Service**

Is the service related more to an employment outcome or education?

That is, is the service usually considered a special education or related service, such as transition planning necessary for the provision of a free appropriate public education?

- **Customary Services**

Is the service one that the school customarily provides under part B of the IDEA?

For example, if the school ordinarily provides job exploration counseling or work experiences to its eligible students with disabilities, the mere fact that those services are now authorized under the Act as pre-employment transition services does not mean the school should cease providing them and refer those students to the Office of Vocational Rehabilitation(OVR) program. However, if summer work experiences are not customarily provided by a local educational agency, the OVR and local educational agency may collaborate to coordinate and provide summer work-based learning experiences.

- **Eligibility**

Is the student with a disability eligible for transition services under the IDEA?

It is possible that a student receiving services under section 504 does not have an individualized education program (IEP) under the IDEA, because they are not eligible to receive special education and related services under the IDEA. As a result, DSUs are authorized to provide transition services under the VR program to a broader population under WIOA than local educational agencies are authorized to provide under the IDEA.
