

## 2021-22 PASA DLM Instruction and Assessment Calendar Enrollment and Testing Windows, Trainings, and Reporting

This calendar provides details regarding the PASA DLM enrollment and testing window and includes dates for required trainings and professional development opportunities. PASA Assessment Coordinators/District Test Coordinators (DTCs) are responsible for sharing this calendar with PASA Assessors and other relevant school personnel. **It should be noted that the [Kite Educator Portal](#) should NOT be accessed between October 1 and December 3, 2021.** PASA Assessment Coordinators/DTCs may begin updating Users records only beginning on December 3, 2021. PASA Assessment Coordinators/DTCs may begin preparing Student/Roster Templates for the 21-22 school year after December 3, 2021, but must not upload templates into Kite Educator Portal prior to January 5, 2022 when the enrollment window starts. December 3, 2021 – February 28, 2022	PASA DLM Required Test Administrator Training (RTAT)	PASA Assessment Coordinators/DTCs <b>*PASA Assessors</b>	<p>This annual, <i>asynchronous</i> training is required for PASA Assessors. It is strongly <i>recommended for PASA Assessment Coordinators/DTCs</i>. The following topics are presented: an overview of the alternate assessment, understanding and delivery of testlets, test administration and scoring, and preparing to administer the test.</p>	<p><b>Access Training</b> Go to the <a href="#">PA DLM Homepage</a> and select Training Courses.</p> <p><b>Training Details</b> New Assessors for 2021-22 will complete the full RTAT consisting of four modules. Returning assessors who completed the RTAT last year will complete an abbreviated refresher training this year. <i>Returning assessors who completed RTAT early because of testing students in September are not required to complete again.</i> The RTAT refresher requires assessors to answer five questions per topic with 80% accuracy. Failure to meet 80% will require assessors to review the full module on the training topic. <b>Time</b> - Refresher course = 1.0 – 1.5 hours and Full course = 2.25 hours.</p> <p><b>Act 48 Availability</b> - Not available; printable certificate upon completion</p>
