01. The Impact of COVID-19 School Closures on Students with Disabilities: What the Attorneys Are Saying

03. Health and Safety Pandemic Planning Specific to Special Education

Intermediate unit and school district special education administrators from across Pennsylvania will share their approaches to mitigating the risk factors specific to the needs of students with disabilities. Pandemic Plan language addressing the physical needs of students with multiple disabilities, the behavioral needs of students with significant social and emotional needs, and the unique challenges related to supporting students with autism and intellectual disabilities will be shared. 04. Equitable Leadership

05. COVID Compensatory Services Guidance/Grants

Recently, the PA Bureau of Special Education released COVID Compensatory Services (CCS) Guidance whereby LEAs, in consultation with IEP teams, must make an individualized determination whether, and to what extent, compensatory services may be needed as a result of the extended school closure. This session will provide further explanation of the CCS process and strategies for delivering CCS. Additionally, session participants will be introduced to a grant opportunity available to school districts and charter schools in need of financial supports to offset costs associated with the development and implementation of a systemic plan to address the need to remedy students' skill and/or behavior loss and/or lack of progress that resulted from the LEA's inability to provide a Free Appropriate Public Education (FAPE) during the extended school closure. Participation in this session is mandatory for school district and charter school personnel interested in applying for a CCS grant.

06. The Hearing Officer Perspective on Virtual Due Process Hearings

Although Pennsylvania hearing officers have been offering Virtual Hearings (VH) for the past five years, VH became the exclusive mode of due process hearings as of March 16, 2020, when schools closed. A panel of hearing officers, including Jake McElligott and Cathy Skidmore will discuss the past four months of due process hearings, and look ahead to the gradual resumption of in-person hearings.

08. Educationally Sound Decision-Making Procedures in Special Education: Child Find Procedures & Evaluation

Participants will be provided with guidelines to establish, reinforce, and communicate the use of Child Find Procedures within their LEAs. Special education evaluations and assessment procedures will also be discussed as a means to provide teams with considerations to meet student needs and avoid possible over identification of students. Content will be reviewed in a manner that is conducive to both a virtual and/or face-to-face environment.

Schools will face many challenges as they consider how to safely re-open and help students recover academically. Critical to this process is addressing the social and emotional needs as students and staff re-integrate back into classrooms, continue to develop connections to the school community and adjust to whatever learning environment. It is vital that schools offer opportunities for processing feelings and experiences, safe expression, and development of coping skills so that all can continue the work of teaching and learning.
