Dear Senator Stevens: .

This is in response to your letter to Scott Fleming, Assistant secretary for the office of Legislation and Congressional Affairs dated December 16, 1998, regarding the disciplining of students with disabilities. Your ,letter to Assistant Secretary Fleming was written on behalf of your constituent, Michael S. Melear, Director, Student Support, Matanuska-Susitna Borough School District. Your constituent's letter is a follow-up to my letter to you dated October 20, 1998, which provides clarification of the Individuals with Disabilities Education Act Amendments of 1997, Pub. L. 105-17 (IDEA '97) regarding the disciplining of students with disabilities. In his letter, Mr. Melear indicates that he is representing the views of other special education directors in Alaska. Based on their concerns, Mr. Melear's letter contains specific recommendations for the Department to consider in implementing the provisions in IDEA '97 applicable to students with disabilities.

I appreciate your writing to share your constituent's concerns with us, and providing this Office with the opportunity to further clarify the relevant requirements of IDEA '97.

IDEA '97 gives school personnel the new authority to unilaterally place a student with disabilities in an interim alternative educational placement for up to 45 days if the student brings a weapon to school or to a school function or knowingly possesses or uses drugs while at _school or a school function. See section 615(k)(1) of IDEA '97. A school district may also ask a hearing officer to order an interim alternative placement for up to 45 days for a disabled student, if the hearing officer determines that the disabled student poses a danger to self or others. See section 615(k)(2) of IDEA '97.

IDEA '97 contains several provisions that would allow States to provide Federal funds to assist in providing alternative placements. Section 611(f)(4) of IDEA '97 creates a new category

of subgrants that State educational agencies (SEAs), under certain circumstances, will make to local educational agencies (LEAs) for capacity building and improvement. The purpose of these subgrants is to address particular needs that are not readily addressed through formula assistance, and to enable SEAS to use these subgrants to promote innovation, capacity building, and systemic improvement.

One of the permissible activities for which these funds can be used is "[d]irect services, including alternative programming for children who have been expelled from school." See section 611(f)(4)(B)(i). These funds could be used to assist in funding the costs of providing appropriate interim alternative educational placements, made in accordance with section 615(k)(1) and (2) of IDEA '97.

The amount of the State's total Part B grant retained by the State for State-level activities also could be used for this purpose. Funds that a State sets aside may be distributed to LEAs, at the State's discretion, in any manner determined appropriate by the State.

On March 12, 1999, the Department published final regulations implementing statutory changes to IDEA made by IDEA '97. Numerous comments were received on the proposed regulations, particularly in the area of student discipline, and these comments were carefully considered in the development of the final regulations. I believe that these regulations help to address the concerns of your constituents who see the need for school personnel to immediately remove a dangerous student from a school in order to ensure the safety of the school environment.
