# Supplementary Aids and Services (SaS) Consideration Toolkit On-Demand Facilitator Training

## **Description:**

The Supplementary Aids and Services (SaS) Consideration Toolkit is a structured method to analyze the instructional, physical, and social environment of a general education classroom from the perspective of an individual student. The intended outcome of using the toolkit is to identify a list of environmentally-referenced supplementary aids and services to enhance participation and learning for a student with a disability in the general education classroom.

This on-demand training is specifically designed to prepare IU TaC and targeted Local Educational Agency (LEA) personnel to become facilitators for student focused teams utilizing the Supplementary Aids and Services Consideration Toolkit. Individuals participating in this training are expected to co-facilitate a SaS Consideration Toolkit with a student team with guidance from an experienced SaS Consideration Toolkit facilitator.

Individuals who complete all components of this on-demand training will be eligible to download and print a certificate of completion.

- Schedule, prepare and facilitate a SaS Consideration Toolkit with guidance from an experienced IU or PaTTAN facilitator
